- Car park passes issued are for a parking space between the hours of 6am and 6pm Monday to Friday ONLY and no other service. Vehicles parked after 6pm will incur the standard Event Parking Charge.
- The Operator reserves the right to alter parking arrangements on occasions where it is deemed necessary for Events giving the Hirer at least 7 days prior notice. The Operator will endeavour to find alternative parking whenever possible but is not obliged to do so.
- The Operator does not accept any liability and the Hirer parks on the premises at their own risk.
- The parking of vehicles is in the Main Arena car park, Overspill Car Park or the Redheugh Bridge Car Park.
- Where necessary pass holders are requested to follow the instructions of the car park stewards.
- Misuse of car park passes will make the pass void.
- Abuse to any member of staff will make the car park pass void and may result in refusal of entry.
- Passes are non-transferable and non-refundable and are issued for the vehicle registration number stated in Schedule 1 only unless otherwise agreed.
- The pass holder must supply a contact telephone number or email address for when the car is parked in the Arena Car Park as stated in Schedule 1.
- Passes must be displayed in the vehicle at all times. Lost passes can be replaced for an admin fee of £5.
